Blitzkrieg Defense Solutions	Bidder failed to comply with conditions of RFB which included, having completed at least 02 contracts of similar goods in the past five years, delivery period was not specified as required under RFB and bid was also found higher than the technically compliant and financially lowest bid
3.	Defence Engineering (Pvt) Ltd.	Bid Security was not provided with the submitted Bid as per BDS ITB 19.1, therefore bid was considered 'Non-responsive' and bid was also found higher than the technically compliant and financially lowest bid
4.	OREL Vision	The bid security furnished by the bidder was considered "non responsive" as it was issued in the name of bidder itself as beneficiary rather than in the name of Purchaser, as specified in the Form of Bid Security. Bidder failed to comply with conditions of RFB which included, having completed at least 02 contracts of similar goods in the past five years and bid was also found higher than the technically compliant and financially lowest bid
